New Business

- By Law Change – Eliminating July 4th Meeting
 - The board will work to update the by laws to reflect removal of July meeting.

- No Wake Signs for O'Brien
 - Current buoys are not

 - Minimum 50' side to side stakes to be put into the sand in 2025. They will be put in/removed each year. Signs were given from the Sheriff's Office (2'x2').

 - Motioned, vote to floor, approved.

Weeds/Tall Vegetation between Lakes

- Between the lakes, proposed weeding along the road (not clearing any large areas/lots), but making it easier to see when driving or for walkers.
- Proposed to trim down (approx. 2'), not disturbing the plant/roots.
- Proposed lower speed limit signs in that area, even if GOLLA funds the cost of the signs.

Wapoa – Tests of Area Lake Water – Look at historical water depths across both lakes.
